

Safety And Security



Currently, he excels as the Principal of De Paul School in Ukkunagaram, Vizag, and has been honored with prestigious awards, including a Doctor of Literature (D.Litt.) and the Best Principal of Karnataka Boarding Schools in 2018.

GENERAL INSTRUCTIONS

- ⇒ School students are expected to be appropriately groomed and dressed at all times.
- ➤ Except for No Uniform days, school uniforms of the specified school colours are compulsory. Shirts must be properly buttoned and tucked into trousers
- ➤ Expensive jewellery should not be worn to school since they could be lost or stolen.
- → A student may not be allowed out of the school premises for any other reason, unless accompanied by a teacher and other students for a field trip or excursion.
- ➤ In case of a serious illness, the school physician will be attending to the child, and up on his recommendation the child needs to be sent home. Parents will be informed to come to the school and take the child home till he/she recovers.
- **⊃** Two days authorized leave may be granted in a year, for attending

- a marriage ceremony of a close member of the family-real sister/ brother, father's brother/sister, mother's brother/sister. In case of death of an immediate family member, or a religious ceremony being observed at home for a special occasion, leaves will be granted.
- → Disruption of studies during termtime is not encouraged and should be kept to the minimum.
- → A student who is returning after an absence is required to bring a letter signed by his parent or guardian giving the date(s) and reason for absence.
- → Utmost cleanliness must be observed in school premises. Throwing litter, pieces of paper, seeds and skins of fruits is strictly prohibited. Use of dustbins provided, should be made for this
- → Writing or scribbling on walls and desk, benches or anywhere else is strictly prohibited.

- ⇒ Any kind of damage done by pupils to the school equipments, furniture, building, etc. will have to make good and penalty shall be decided by the Principal.
- ⇒ Strict regularity, implicit obedience, politeness, courtesy in speech and conduct and cleanliness of books, dress and person are rigidly insisted upon.
- Silence must be observed in the corridors and on the stairs during class hours. They should not be found talking during transit periods.
- No books (other than text or library books), newspapers or periodicals must be brought to school. Any objectionable literature found in possession of the student justifies dismissal.
- ⇒ The school shall not be held responsible for books, money, and other articles that are lost. Students must look after their own things. It is not advisable for pupils to have money, valuable articles or jewellery with them. Harmful or lethal objects should not be brought

to school. Beware; it is a criminal offence to carry harmful or lethal objects.

- → Mobile Phones are not permitted in the school premises. Any student found carrying a mobile phone, the phone will be confiscated and a heavy penalty will be levied.
- ⇒ Pupils are answerable to the school authorities for their conduct both in and even outside the school. Hence misbehaviour in public places and conveyance is punishable. Every student should endeavour to keep up high tone of the school, by excelling in good manners and deportment.
- Students must not run around inside the school building. They must observe silence while walking through

- the corridors or while going up and down the staircase.
- Wrist bands bangles, goggles, fancy pins; mehandi, flowers etc. are strictly not allowed to be worn in the school. However girls may wear small bindi and small earrings.
- ➤ Wearing tattoos, studs, coloring of hair are strictly prohibited and will invite heavy penalty.
- ⇒ Hair Do:
 - For Girls a folded two plait with ribbons for long hair and a band for short hair.
 - For Boys a buzz cut or a brush cut.
- ➡ It is necessary to change socks daily. Only Sikh students who wear turbans will be allowed to keep a beard. The other boys should be clean shaven.
- **⊃** The Principal reserves the right to monitor all correspondence received by students through the school.
- Written permission from the Principal is required for the following:





- > Collections for any purpose,
- Organizing meetings, parties, picnics, etc.,
- Leaving school premises during school hours.
- > Giving presents to staff members,
- Organizing and conducting competitions and matches with other schools.





HOUSE SYSTEM

The whole school (students and staff) has been put up into four houses viz, Venus House, Ceres House, Iris House & Janus House. Inter- house competitions among the houses throughout the year foster a healthy spirit of competition and excellence in performance of students.

DRESS CODE

A student must wear uniform with pride and ensure that they look neat and presentable at all times. Students' identity card is part of the uniform. On all working days, students are to wear the school uniform failing which, they will not be allowed to attend class.

On their birthdays, students could wear dresses of their choice provided these are modest and dignified. Uniform should be worn as per the following specifications.

• LKG & UKG Boys:

Checked short pants, white shirt, navy blue socks with stripes, black shoes.

• LKG & UKG Girls:

Checked tunic with an attached white shirt, navy blue socks with stripes, black shoes.

• Boys: 1st to 6th:

Navy Blue short pants, checked shirt, navy blue socks with stripes, black shoes, and belt with school emblem.



7th to 10th:

Navy Blue trousers, checked shirt, navy blue socks with stripes, black shoes, and belt with school emblem. (Blue & white stripes tie for 8th to 10th boys only)

• Girls: 1st & 2nd:

Checked tunic, navy blue socks with stripes, black shoes, and belt with school emblem.

• 3rd to 6th:

Checked tunic, Navy blue shirt, navy blue socks with stripes, black shoes, red ribbon, and belt with school emblem.

• 7th to 10th:

Checked Kurti and Navy Blue Waist coat & Salwar, navy blue socks with stripes, black shoes & red ribbon.

N.B. Tunic & Kurties should be Knee length.

SPORTS UNIFORM

(Wednesday & Saturday)

- Boys: Cream colour pants, (Short pants for 1st to 6th and trousers from 7th to 10th), House colour T-Shirt (with school emblem), white canvas shoes and navy blue socks
- Girls: Cream colour skirt (1st to 6th), House colour T-shirt (with school emblem), white ribbon, white canvas shoes and navy blue socks. Cream Kurta and Salwar with house colour waistcoat (7th to 10th).
- Boys & Girls: In winter plain red sweater with school emblem. (No caps or mufflers) Care must be taken that the uniform is washed and pressed well and worn with clean socks and polished black shoes. Failure to comply with the aforementioned rules will result in disciplinary action.

N.B. No jewellery, ornaments or flowers are to be worn to school.

- > Issue of Admission Registration forms for Classes LKG to 7th will be in January during the office hours
- Registration will be closed without prior notice.
- Admission will be purely based on merit.
- Fee Structure and Bus transport details will be published on the school notice board.
- All payments are to be made at the school office only.

REQUIREMENTS/STEPS FOR REGISTRATION & ADMISSION

- Produce Photocopy of Birth Certificate and 2 colour photographs.
- II language chosen during registration cannot be altered at later stage.

- Affix a recent colour photograph on Registration form.
- The filled in registration form details should be according to Birth Certificate. It should be submitted to school office to receive the admit card
- Admit Card is mandatory for Counseling and Assessment.
- Once Admission is confirmed, pay and collect the Admission Application Form from the School Fee Counters.
- Fill in, attach the mandatory certificates and submit the form to the School Fee Counters along with initial fees.
- There will be a mandatory verification of all the original documents along with the Admission form before completing the admission process.
